Finally even if this division is approved, I understand zoning, local ordinance and State Acts change from time to time, and if changed the divisions made here must comply with the new requirement(apply for division approval again) unless deed, land contracts, leases or surveys representing the approved divisions are recorded with the Register of Deeds or the division is built upon before the change to the laws were made.
